## 2. COMPOSITION / INFORMATION ON INGREDIENTS

## 3. HAZARDS IDENTIFICATION

**Main hazards:** Highly flammable. Harmful by inhalation.  
**Other hazards:** In use, may form flammable / explosive vapour-air mixture.

## 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be irritation and redness at the site of contact. Blistering may occur.  
**Eye contact:** There may be irritation and redness. The vision may become blurred.  
**Ingestion:** There may be irritation of the throat. There may be vomiting. Inhalation of fumes from the stomach may cause symptoms similar to direct inhalation.  
**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest. Drowsiness or mental confusion may occur. There may be loss of consciousness. There may be congestion of the lungs causing severe shortness of breath.

## 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water. Consult a doctor.  
**Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.  
**Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Transfer to hospital as soon as possible.  
**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible.

## 5. FIRE-FIGHTING MEASURES

**Extinguishing media:** Carbon dioxide. Alcohol or polymer foam. Dry chemical powder. Use water spray to cool containers.  
**Exposure hazards:** Highly flammable. Vapour may travel considerable distance to source of ignition and flash back.

Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide.

**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions:** Do not attempt to take action without suitable protective clothing - see section 8 of SDS.  
Eliminate all sources of ignition. Turn leaking containers leak-side up to prevent the escape of liquid.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using bunding.

**Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method. Wash the spillage site with large amounts of water.

**7. HANDLING AND STORAGE**

**Handling requirements:** Ensure there is sufficient ventilation of the area. Smoking is forbidden. Avoid the formation or spread of mists in the air.

**Storage conditions:** Store in cool, well ventilated area. Keep away from sources of ignition. Keep container tightly closed.

**Suitable packaging:** Must only be kept in original packaging.

**8. EXPOSURE CONTROLS / PERSONAL PROTECTION**

**Engineering measures:** Ensure there is sufficient ventilation of the area. Ensure lighting and electrical equipment are not a source of ignition.

**Respiratory protection:** Respiratory protective device with particle filter.

**Hand protection:** PVC gloves. Butyl gloves.

**Eye protection:** Safety goggles. Ensure eye bath is to hand.

**Skin protection:** Protective clothing, PVC.
